PUBLIC PARTICIPATION

Members of the public may observe and raise subjects that they wish to bring to the attention of the Town Council. Items relating to matters on the agenda will be taken first and the time will be restricted to 30 minutes maximum unless the council decides otherwise. A member of the public shall not speak for more than 5 Minutes. Observers should note that decisions cannot be made at this meeting on items not on the agenda.

RECORDING OF MEETINGS

This council supports the right of anyone to record this meeting but advises that anyone so recording cannot disrupt the meeting by means of the recording and expresses the hope that the person (or persons) carrying out the recording has obtained the necessary legal advice to ensure they understand the rights of any members of the public present who do not wish to be filmed or recorded. The Public Participation period is not part of the Council Meeting as such, and legal advice should be taken as to the recorders' rights to make recording during that period.
